

User Agreement

This User Agreement (hereinafter referred to as the Agreement) was developed in order to:

- obtain Consent to the processing of personal data of persons searching for and posting information (hereinafter referred to as Users) on the resource <https://profitserver.ru> (hereinafter referred to as the Site), by the operator of personal data (hereinafter referred to as the Administration);
- determining the conditions for using the Site by Users.

By registering on the Site, sending an application to the Site, the User undertakes to accept the Consent to the processing of personal data, as well as by registering on the Site, the User confirms that he has read and agrees with the terms and procedure for using the Site. Registration of the User on the Site is an acceptance of the Agreement.

Consent to the processing of personal data

I give my consent to the processing of my personal data by the Limited Liability Company "Profitserver" (Identification number 402176523, legal address: Georgia, 0159 Tbilisi, Didube district, Ljubljana st., 3-146, E-mail: info@profitserver.net) and I confirm that by giving such consent, I am acting on my own and in your interest.

Consent applies to the following information: last name, first name, patronymic, phone number, email, place of residence and any other information related to my personality.

- I give consent to the processing of personal data in order to receive products (goods, works, services) of the Administration in which I am interested, to carry out mailings.

Consent is granted to take any actions in relation to Personal Data that are necessary to achieve the above goals, including without limitation: collection, systematization, accumulation, storage, clarification (update, change), use, distribution (including transfer), depersonalization, blocking, destruction, as well as the implementation of any other actions with personal data in accordance with applicable law.

The processing of personal data is carried out by the Administration in the following ways:

- processing of personal data using automation tools;
- processing of personal data without using automation tools (non-automated processing).

When processing personal data, the Administration is not limited in the use of methods for their processing.

I hereby acknowledge that the Administration has the right to provide third parties with my personal data if:

- I give my express consent to the transfer of my personal data to third parties;
- the disclosure of my personal data is necessary for the provision of services to me and / or for the processing of my personal data. In the event that the Administration

transfers my personal data to third parties, the Administration requires third parties to respect the confidentiality of my personal data of the User.

This consent is given before the expiration of the storage period for the relevant information or documents containing the above information, determined in accordance with the current legislation of Georgia, after which it can be revoked by sending me a written notification to the Administration at least 1 (one) month prior to the withdrawal of consent.

Warranty.

The user guarantees:

- the information provided by him is complete, accurate and reliable;
 - when providing information, the current legislation of Georgia, the legal rights and interests of third parties are not violated;
 - all information provided to the site is filled in by the User in relation to himself personally, all registration actions on the site are performed directly by the User;
 - that he does not use other people's contact information, including telephone, e-mail, etc .;
 - does not interfere with the use of the Site by other Users, including through the spread of computer viruses, repeated posting of duplicate information, the simultaneous sending of a large number of e-mails or requests to the Site, etc.;
 - does not transfer information to third parties regarding the login and password on this site.
- All information received under the User's registration data will be considered received from him personally.

The User has been informed:

The Administration has the right, at its discretion, to delete the User's information from the site in cases of doubt about the User's compliance with the terms of this Agreement.

Other conditions: The

user understands and agrees that the information and contact information posted by him can be used by search or other automated services and in other ways.

Responsibility of the parties:

If the User has posted information, the dissemination of which is restricted or prohibited by the laws of Georgia, violates copyright or other rights protected by law, the User bears full responsibility for its placement.

Time and conditions of the Agreement:

This agreement enters into force from the moment the User's personal data is received on the site and extends its effect for an indefinite period.

The administration has the right to unilaterally change the provisions of the Agreement. The current version of the Agreement is posted by the Administration on the Site.
